We also produce in-depth feature articles on art-related topics for a wide audience, and we maintain a dynamic website. In 2021, we received 16 awards (bringing our total to 27) from the San Diego Press Club for Excellence in Arts Journalism, including Best Entertainment Website in San Diego. Our arts coverage is comprised of THE BUZZ, featuring artist interviews, show reviews, and behind-the-scenes insight into San Diego Arts & Culture; POETIC LICENSE, featuring beautiful photo essays of artist studio visits; the importance of quality arts journalism because it aligns with our mission to create arts jobs, bring diverse communities together, and inspire creative collaboration. Increased coverage of San Diego's vibrant arts and culture sector helps inspire new generations of arts supporters and patrons, which in turn supports arts jobs across the region.

4b (Code: ) (Expenses \$ 4,774 including grants of \$ ) (Revenue \$ 471 ) PROFESSIONAL DEVELOPMENT: We provide multiple opportunities for San Diego's Creative Industry Professionals to increase their skills and broaden their horizons, such as a legal symposium for artists; and forums such as INSPIRE, where we brought notable arts leaders together to share what has inspired them most in their careers. Professional development in the form of industry workshops, lectures, panel discussions, and meaningful networking opportunities (all in virtual and in-person formats) are a key component of our programming. We believe in providing industry professionals with the tools, resources, and opportunities to become better at their craft and to make a living doing what they love.

Our events appeal to Creative Industry Professionals as well as to the public at large and provide opportunities for guests to connect in meaningful ways and leave feeling that they've experienced something truly special that cannot be replicated. Our programmatic partners are some of the region's most notable cultural organizations including the San Diego Opera, the San Diego Symphony, The Museum of Photographic Arts, Fashion Week San Diego, San Diego Italian Film Festival, Baja Wine + Food, San Diego Latino Film Festival, and many more. ## General Information

In general, for taxable years beginning on or after January 1, 2015, California law conforms to the Internal Revenue Code (IRC) as of January 1, 2015. However, there are continuing differences between California and federal law. When California conforms to federal tax law changes, we do not always adopt all of the changes made at the federal level. For more information, go to [ftb.ca.gov](http://ftb.ca.gov) and search for **conformity**. Additional information can be found in FTB Pub. 1001, Supplemental Guidelines to California Adjustments.

The instructions provided with California tax forms are a summary of California tax law and are only intended to aid taxpayers in preparing their state income tax returns. We include information that is most useful to the greatest number of taxpayers in the limited space available. It is not possible to include all requirements of the California Revenue and Taxation Code (R&TC) in the instructions. Taxpayers should not consider the instructions as authoritative law.

## A Purpose

Use form FTB 3885F, Depreciation and Amortization, to compute depreciation and amortization allowed as a deduction on Form 541, California Fiduciary Income Tax Return, Form 109, California Exempt Organization Business Income Tax Return, or Form 199, California Exempt Organization Annual Information Return. Attach form FTB 3885F to Form 541, Form 109, or Form 199.

Depreciation is the annual deduction allowed to recover the cost or other basis of business or income producing property with a determinable useful life of more than one year. Land is not depreciable.

Amortization is an amount deducted to recover the cost of certain capital expenses over a fixed period.

## B Federal/State Differences

California law has not always conformed to federal law regarding depreciation methods, special credits, or accelerated write-offs.

Consequently, the recovery periods and the basis on which the depreciation is calculated may be different from the amounts used for federal purposes. Reportable differences may occur if all or part of your assets were placed in service:

- **Before January 1, 1987.** California disallowed depreciation under the federal Accelerated Cost Recovery System (ACRS). California depreciation is calculated in the same manner as in prior years for those assets.
- **On or after January 1, 1987.** California provides special credits and accelerated write-offs that affect the California basis for qualifying assets. California does not conform to all the changes to federal law enacted in 1993. Therefore, the California basis or recovery periods may be different for some assets.
- **On or after September 11, 2001.** California has not conformed to the federal Job Creation and Worker Assistance Act of 2002 which allows taxpayers to take an additional first year depreciation deduction and Alternative Minimum Tax depreciation adjustment for property placed in service after September 10, 2001.
